





# 2025 IMPACT INVESTING DAYS CALL FOR PAPERS

The Impact Investing Days are a discussion forum for impact investing practitioners, social entrepreneurs, and academics. The conference aims to challenge current practice and use evidence-based research to develop better insights into the links between social and environmental impact, financial returns, and investment decisions.

The first day of the conference features keynote talks and panel discussions aimed at encouraging debates between academics, policy-makers and practitioners which critically reflect upon current impact investing practices. The second day features presentations of academic papers at various development stages to capture the latest ideas. We aim to attract high-quality research contributions with a strong likelihood to improve practices and policies.

## Paper Submission Process and Deadlines

Discussion Panels. We encourage proposals for interactive discussion panels that explore practical insights, real-world experiences, and emerging trends related to impact investing. Panels will systematically mix academics with practitioners (impact investors, social entrepreneurs, impact evaluators, etc.) and, when relevant, policy-makers at different levels (local, national, international).







Panel proposals should include a brief abstract outlining the topics to be covered and the names and affiliations of 1-2 practitioners or policy-makers and 1-2 academics. Please pre-confirm with the expected panelists their availabilities. Submission 5<sup>th</sup> deadline for discussion panels: January 2025.

- Academic Research Papers. We invite researchers to submit original, previously unpublished academic papers on topics related to impact investing. Submissions should present rigorous research that contribute to the theoretical, empirical, or practical understanding of impact investing. All papers will undergo a double blinded peer-review process to ensure the quality and relevance of the content. Submit either a full paper or an extended abstract as a single blinded PDF document. Every paper will be discussed by a dedicated discussant.
- Submission deadline for academic papers: January 5<sup>th</sup> 2025.
- PhD Workshop. We invite PhD students working in the impact investing field to attend the PhD workshop on April 4<sup>th</sup>. This specific moment, dedicated to junior scholars, will contribute to building an international community of impact investing researchers, to improve their research projects, methodological skills and to share empirical and theoretical opportunities.

Submissions should be written in English. They must be submitted as PDF. For full academic papers, the word limit should not exceed 40 double spaced pages of text in Times new Roman 12 font, which includes title page, abstract (of 100 words or less), tables and figures, and list of references. A separate PDF should include the title page full name(s) of authors and affiliations. Proposals at any stage of development are welcome. Extended abstracts (minimum 10 pages) can also be accepted.
